ABOUT TENNESSEE GRASSLANDS GOLF AND COUNTRY CLUB

In 2018 The Club at Fairvue Plantation acquired Foxland Harbor Golf and Country Club and Tennessee Grasslands Golf and Country Club was born. Located just 25 minutes from downtown Nashville and nestled on the shores of Old Hickory Lake in Gallatin, Tennessee, is a private golf and country club with two club properties approximately three miles apart. Both properties feature 18-hole championship-caliber golf courses, beautiful clubhouses, pools, fitness centers, and multiple dining options. In addition, the Fairvue site features a new nine-hole short course, four clay tennis courts (that are domed for a 20-week indoor tennis season), two pickleball courts, and a new golf performance improvement center. The Foxland site features a newly constructed 7,800-square-foot event center.

The Fairvue Clubhouse is currently undergoing an extensive renovation and expansion project with an expected opening date in the summer of 2025. The Fairvue golf course and pro shop are fully operational during this time.

CLUBHOUSE MANAGER JOB DESCRIPTION

The Clubhouse Manager at Tennessee Grasslands is responsible for the overall management and operation of the clubhouse, ensuring the highest level of service and satisfaction for club members and guests. This role will encompass the coordination and supervision of all clubhouse activities, including dining services, events, maintenance, and pool operation.

KEY RESPONSIBILITIES

- Embrace the Mission, Vision, and Purpose of Tennessee Grasslands.
- Oversee daily operations of the clubhouse, including dining services, events, and facilities management.
- Have a strong, highly visible, and respectful presence with the members.
- Ensure exceptional member experiences by maintaining high standards of service and addressing member needs promptly and effectively.
- Develop and implement programs and services that enhance member satisfaction and engagement.
- Develop and maintain strong relationships with members, understanding their needs and preferences.
- Engage with members regularly to ensure they are informed about club activities and services.
- Handle member feedback, complaints, and concerns professionally and effectively, working to resolve issues to the satisfaction of all parties.
- Work with club leadership to develop and implement strategic plans for clubhouse operations.
- Identify opportunities for innovation and improvement in clubhouse services and amenities.
- Stay current with industry trends and best practices to ensure the clubhouse remains competitive and attractive to members.
- Recruit, hire, train, and manage clubhouse staff, ensuring they provide excellent service and adhere to club
 policies and procedures.
- Develop and implement comprehensive training programs for all areas of responsibility.
- Conduct regular performance evaluations and provide ongoing training and professional development opportunities for staff.
- Foster a positive, collaborative, and professional work environment.
- Collaborate with other department heads to ensure a seamless and integrated member experience across all club services.
- Participate in management meetings to coordinate activities and share updates.
- Work with the marketing team to promote clubhouse events and services to members.
- Develop and implement initiatives to increase member engagement and participation.
- Develop and manage the clubhouse budget, ensuring financial goals are met and costs are controlled.
- Monitor financial performance, prepare and analyze financial reports, and make recommendations for improvement.
- Oversee inventory management and procurement for clubhouse operations.
- Coordinate and manage all clubhouse events, including member events, private parties, club functions, and outside events.
- Work with the event team to plan and execute events that meet member expectations and club standards.
- Ensure all events are well-coordinated and executed smoothly.
- Oversee the maintenance and upkeep of clubhouse facilities, ensuring all areas are in good repair and aesthetically pleasing.
- Coordinate with the facilities team to address maintenance issues and improvements promptly.
- Ensure the clubhouse operates in compliance with all health, safety, and environmental regulations.
- Conduct regular safety audits and training sessions to maintain a safe environment for members and staff.

CANDIDATE QUALIFICATIONS

- Minimum of five years of management experience in a similar high-end club or like environment.
- Strong leadership and team management skills.
- A fundamental understanding of the premier club experience and the proven ability to execute to that level.
- Skilled in hiring, supervising, managing, mentoring, and developing high-achieving employees.
- Organized, consistent, detail-oriented, and can multi-task and prioritize.
- A patient, professional demeanor with superior verbal and written communication skills.
- Verifiable track record of successfully leading and growing dynamic clubhouse operations, including building revenues, controlling costs, and meeting or exceeding planned and budgeted bottom-line goals and objectives in food and beverage operations.
- Proficient with Microsoft Office Suite, report generation, and membership database management.

- Extensive knowledge of all areas of clubhouse operations and a strong Food and Beverage background.
- Strong communication and facilitation skills, both written and verbal, with the appropriate personal presence, and a desire and ability to interact effectively before diverse constituencies of members, staff, vendors, and guests.
- Confident in his or her abilities yet humble in his or her interactions.
- A good sense of humor and an ability to have fun.
